What is a battery energy storage system?

A battery energy storage system (BESS) is an electrochemical devicethat charges (or collects energy) from the grid or a power plant and then discharges that energy at a later time to provide electricity or other grid services when needed.

Are batteries a viable energy storage technology?

Batteries have already proven to be a commercially viable energy storage technology. BESSs are modular systems that can be deployed in standard shipping containers. Until recently, high costs and low round trip efficiencies prevented the mass deployment of battery energy storage systems.

Batteries and similar devices accept, store, and release electricity on demand. Batteries use chemistry, in the form of chemical potential, to store energy, just like many other everyday energy sources. For example, logs and oxygen both store energy in their chemical bonds until burning converts some of that chemical energy to heat.
