Why do energy storage projects need project financing?

The rapid growth in the energy storage market is similarly driving demand for project financing. The general principles of project finance that apply to the financing of solar and wind projects also apply to energy storage projects.

Is energy storage a good investment?

Also note that energy storage has played an increasingly prominent role for investors in this sector. For a different perspective, let's look at the Bloomberg New Energy Finance assessment of total investment in the clean energy sector globally between 2004 and 2018. The last five years have generated over \$300B in investments to the sector.

Do project finance lenders consider technology risks in energy storage projects?

Project finance lenders view all of these newer technologies as having increased risk due to a lack of historical data. As a result, a primary focus for lenders in their due diligence of an energy storage project will be on technology risks.

What will JD energy's 5gwh funds be used for?

Can you finance a solar energy storage project?

Since the majority of solar projects currently under construction include a storage system, lenders in the project finance markets are willing to finance the construction and cashflows of an energy storage project. However, there are certain additional considerations in structuring a project finance transaction for an energy storage project.

It has traditionally been difficult to secure project finance for energy storage for two key reasons. Firstly, the nascent nature of energy storage technology means that fixed income lenders and senior debt providers are naturally risk averse. Battery storage has less of a track record than other renewable energy assets such as solar and wind ...
